

Calls: 7-10 calls to 4-5 vendors

Costs: \$800 - \$2,400

# Arrangements with receiving funeral home

Calls: 1 or more

Transporters: \$300 - \$800

#### FREQUENTLY ASKED QUESTIONS

### What needs to happen to qualify for Plan benefits?

After making a low membership fee,
Plan members are eligible for benefits
if they pass away 75 or more miles
from their legal home address. Additionally, the Plan member's nextof-kin must call IEA first, rather than
calling other transport or deathcare
providers.

### What if a Plan member dies while traveling internationally?

IEA will facilitate and coordinate all details and arrange transport in accordance with the member's benefits, provided the international location is more than 75 miles from the Plan member's home of record.

# Who administers the Plan and who manages the services when needed?
